

Waiver of Liability

By signing this agreement, I/We agree to hold **Pawlett Sports & Playing Fields Association** entirely free from any liability, including financial responsibility for injuries incurred, regardless of whether injuries are caused by negligence.

I/we also acknowledge the risks involved in **using the 3G five aside pitch**. These include but are not limited to **slips trips & falls, access and egress, fence proximity**. I/we swear that I/we are participating voluntarily, and that all risks have been made clear to me/us. Additionally, I/we do not have any conditions that will increase my/our likelihood of experiencing injuries while engaging in this activity.

By signing below I/we forfeit all rights to bring a suit against **Pawlett Sports & Playing Fields Association (Pawlett Pavilion)** for any reason.

I/we will also make every effort to obey safety precautions as listed in writing and as explained to me/us verbally. I/we will ask for clarification when needed.

- The Hirer shall ensure that the correct footwear is worn at all times by those using the facility. The wearing of boots with metal studs, spikes or blades is strictly prohibited.
- The Hirer will ensure that the soles of their correct footwear will be clean and free of any debris prior to entering pitch area.
- The Hirer will be responsible for providing their own first aid cover and a mobile telephone for emergency assistance if it were to be necessary.
- It is prohibited to take drinks or food of any kind on to the pitch area.
- Smoking is not permitted within the pitch area.
- In the event of the facility or any part thereof being rendered unfit for the use for which it has been hired, Pawlett Pavilion shall not be liable to the Hirer for any resulting loss or damage whatsoever.
- At the end of the hiring, the Hirer shall be responsible for leaving the premises in a clean and tidy condition.
- All Hirers must ensure that they vacate the facility at the stated hired time to allow other hirers to access the facility at their allotted time slot.
- All Hirers will be required to give a minimum of 24 hours' notice to cancel their booking or they will be charged as normal.

Fence Proximity (Collision, Cuts, Broken Bones)	H	Do Not Climb Fencing. Be Aware Pitch Has No Run Off Area. Extra Care When Making Contact With Other Players Close to Fence Line.	M
